RACE 1: GREAT NORTHERN / SABOIS MAIDEN PLATE - 1390 Metres

OUR JOURNEYMAN (S. Logan) - raced keenly in the early stages of the event. Inside the 1200 metres was obliged to be steadied when racing in restricted room to the inside of BRAZEN HEAD, which rolled in.

BRAZEN HEAD (M. Collett) - inside the 1200 metres rolled in and away from ROCKFACE LOUIE tightening the running of OUR JOURNEYMAN. Laid in, in the straight.

RACE 2: LINCOLN SAND SUPPLIES - NT & DA DICKSON / SABOIS MAIDEN HANDICAP -1000 Metres

The start of this event was delayed approximately three minutes.

THE BIG GOODBYE (J. Toeroek) - raced wide without cover throughout the event.

JACKS 'N' DANIEL'S (C. Jones) - raced keenly in the early stages of the event.

ZEGRESTO (S. Fawke) - slow into stride. Difficulty obtaining clear running from the 300 metres until inside the 200 metres and elected to shift to the outside of the field to obtain clear ground.

CARALUE (T. Voorham) - difficulty obtaining clear running in the straight.

KAMALA KHAN (K. Zechner) - a post-race veterinary examination revealed the mare to be lame near foreleg. Trainer, Mr T. Trenowden, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start. First aid administered.

RACE 2: LINCOLN SAND SUPPLIES - NT & DA DICKSON / SABOIS MAIDEN HANDICAP
-1000 Metres (Cont'd)

MY CAT BALLOU (E. Boyd) - laid out from the 400 metres until the finish.

RACE 3: LINCOLN ESTATE WINES BENCHMARK 54 HANDICAP - 1390 Metres

The start of this event was delayed approximately two minutes.

TYCOON DREAMING (S. Logan) - difficulty obtaining clear running in the straight.

GOTTABITON (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

SPENCER GULF (K. Crowther) - jumped away awkwardly and shifted in. Raced keenly in the early and middle stages of the event. Laid in, in the straight.

KHANI STAR (S. Fawke) - jumped away awkwardly.

RAYLEIGH (A. Jordsjo) - dislodged rider en route to the barrier. Rider was examined by the First Care Medical Personnel and ruled unfit to ride. RAYLEIGH was a late scratching by order of Stewards at 1.59 pm as there was no other rider available. Following the running of Race 3, A. Jordsjo was again examined by the First Care Medical Personnel and fit to fulfil her remaining engagements.

RACE 4: VETS ON EYRE BENCHMARK 54 HANDICAP - 1390 Metres

REIGNING IN PARIS (S. Logan) - laid out in the straight.

THE MOSHIRE (S. So) - in the vicinity of the 1000 metres improved onto the heels of GIVEPEACE A CHANCE and was obliged to be restrained.

RACE 5: SA THOROUGHBRED BREEDERS BENCHMARK 58 HANDICAP - 1210 Metres

MISTA KNOWITALL (E. Boyd) - slow to begin.

COPPERFIELDS (S. Fawke) - rider reported the gelding hung out throughout the event. A post-race veterinary examination revealed an irregular heartbeat. Trainer Mr R. Dawson was advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

SCENIC MINT (M. Collett) - laid out from the 400 metres. At the entrance to the straight rolled out tightening the running of DOWNS AFTER DARK. Inside the 200 metres was inconvenienced by FEARLESS AL.

FEARLESS AL (S. Logan) - jumped away awkwardly. Raced in restricted room shortly after the start for a number of strides. Laid in from the 400 metres. At the entrance to the straight, shifted in tightening the running of DOES AFTER DARK. Inside the 200 metres shifted in and inconvenienced SCENIC MINT. Rider reminded of her obligations and advised to make a greater effort to keep her mounts straight.

DOWNS AFTER DARK (A. Jordsjo) - at the entrance to the straight became disappointed for a run between SCENIC MINT and FEARLESS AL, which both shifted ground and was obliged to be steadied. A post-race veterinary examination revealed a bi-lateral bleed. Trainer, Mr T. Montgomerie was advised that as this was the gelding's first bi-lateral bleed it would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

RACE 5: SA THOROUGHBRED BREEDERS BENCHMARK 58 HANDICAP - 1210 Metres (Cont'd)

SPIRITOS (S. So) - laid out in the straight.

RACE 6: AVIS PORT LINCOLN BENCHMARK 58 HANDICAP - 1210 Metres

The start of this event was delayed approximately one minute.

MY MATE SONNY (E. Annells) - underwent a pre-race veterinary examination as it got its leg up in the barrier and passed fit to race. Jumped away awkwardly, shifted in and contacted **DASKULYA**. Raced greenly in the straight.

TAJAVEDO (E. Boyd) - approaching the 100 metres was obliged to be steadied to avoid the heels of **REGINA DEL DRAMMA**, which shifted out.

REGINA DEL DRAMMA (D. Caboche) - laid out in the straight. Approaching the 100 metres shifted out when insufficiently clear of **TAJAVEDO**. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence at midnight on Wednesday, 4 November and to conclude at midnight on Wednesday, 11 November 2020: a period of four meetings which will begin at the conclusion of the suspension imposed on Saturday 24 October 2020.

JETTA JAE (J. Toeroek) - raced in restricted room shortly after the start for a number of strides. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow E. Boyd (**TAJAVEDO**) placed 6th to view the vision in the straight.

RACE 7: HYGAIN - FEEDING CHAMPIONS BENCHMARK 64 HANDICAP - 1390 Metres

PAULO PACE (M. Collett) - rider explained the gelding travelled well in the early and middle stages. When placed under pressure inside the 500 metres failed to respond to her riding and was disappointing to the finish. A post-race veterinary examination revealed abrasions to the lateral bulb of the near fore hoof and to the near hind coronet.

DOCTOR DOOLITTLE (J. Toeroek) - rider explained the gelding did not let down in the straight as expected. A post-race veterinary examination revealed no visible abnormalities.

WITCH KID (T. Pannell) - slow to begin.

SHINSEKI (S. Logan) - jumped away awkwardly and shifted in.

RACE 8: MAGIC 89.9 THE HIT MUSIC STATION BENCHMARK 54 HANDICAP - 1000 Metres

OBLIQUE LINE (S. Logan) - jumped away awkwardly and as a result was slow to begin.

CHINESIS (A. Jordsjo) - bumped on jumping away.

MAIDEN GRACE (E. Annells) - jumped away awkwardly and shifted out and bumped **CHINESIS**. Laid out under pressure in the straight.
