Report on Race Meeting held at Port Lincoln Racecourse

RACE 1: SCHWEPPE SOLO BENCHMARK 80 HANDICAP - 1210 Metres

GO THE JOURNEY (C. Jones) - jumped away awkwardly and was slow into stride. Raced keenly in the early and middle stages of the event. Rider explained that it was her intention to take up a more forward position in today's event; however, due to how the gelding had jumped away she was unable to do so. A post-race veterinary examination revealed no visible abnormalities.

EXCELTARA (M. Collett) - underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Had difficulty obtaining clear ground at the entrance to the straight when awkwardly placed on the heels of MIRTHDALE. Laid in under pressure in the straight. Stewards questioned the rider in relation to her tactics at the entrance to the straight. M. Collett explained that she had always intended to improve to the outside of MIRTHDALE; however, due to her mount laying in she was unable to do so until near the vicinity of the 200 metres.

TICKLE ME ERNIE (E. Boyd) - raced keenly in the early and middle stages of the event. Hung out from the vicinity of the 600 metres until the entrance to the straight.

RACE 2: CARLTON DRY / SABOIS MAIDEN PLATE - 1210 Metres

BONIFACE (NZ) (S. Logan) - laid out rounding the home turn. In the vicinity of the 50 metres was inconvenienced when contacted by BRAZEN HEAD.

SONAR ECHO (E. Boyd) - laid in under pressure in the straight and in the vicinity of the 100 metres was momentarily held up when racing behind EIGHT OVER EIGHT. Approaching the finish was forced to race in restricted room.

RIGHT TURN (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

RACE 2: CARLTON DRY / SABOIS MAIDEN PLATE - 1210 Metres (Cont'd)

DARK SENTRY (A. Jordsjo) - underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. Rider reported that the mare was not comfortable in its action and did not stretch out when placed under pressure in the straight. A post-race veterinary examination revealed a higher than expected hear rate.

ZEGRESTO (S. Fawke) - jumped away awkwardly and was slow to begin.

BRAZEN HEAD (M. Collett) - inclined to shift about under pressure in the straight and in the vicinity of the 50 metres shifted out and bumped **BONIFACE** (NZ).

STRIP CLUB (L. Halliday) - raced wide without cover throughout the event. Inclined to lay in under pressure in the straight.

RACE 3: JP CABINETS / SABOIS MAIDEN PLATE - 1210 Metres

BADOS (S. Fawke) - rider could offer no explanation for the gelding's poor performance. A post-race veterinary examination revealed a higher than expected hear rate.

CANIMAN (L. Halliday) - slow to begin.

DIVINE SUCCESS (S. Logan) - struck an outside rail en route to the barrier. Underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start.

ROCKFACE LOUIE (E. Annells) - jumped away awkwardly. Rider accidentally dropped her whip in the vicinity of the 200 metres.

MY CAT BALLOU (E. Boyd) - rider could offer no explanation for the filly's performance. A post-race veterinary examination revealed a higher than expected hear rate.

RACE 4: TUNARAMA COACHLINES BENCHMARK 58 HANDICAP - 1390 Metres

TROGIR (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

MY MATE SONNY (E. Annells) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

EMOJI (S. So) - jumped away awkwardly. Raced wide without cover throughout the event. Rider was reminded of her obligations under AR132(6)(c) for using her whip when her horse was out of contention.

RACE 5: AVIS PORT LINCOLN BENCHMARK 62 HANDICAP - 1750 Metres

ONWARD (E. Annells) - inclined to lay out under pressure in the straight. Rider reported that the gelding hung out and was on its wrong leg throughout the event.

ARTFULABEERS (J. Toeroek) - shifted in, in the vicinity of the 1650 metres onto **TYCOON DREAMING**. Rider reminded of his obligations when shifting ground. A post-race veterinary examination revealed a higher than expected heart rate.

CRAZY CULPRIT (C. Lions) - raced keenly in the middle stages of the event. Contacted in the vicinity of the 50 metres by **TYCOON DREAMING**, and shortly after shifted back out onto that gelding. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: AVIS PORT LINCOLN BENCHMARK 62 HANDICAP - 1750 Metres (Cont'd)

TYCOON DREAMING (S. Logan) - in the vicinity of the 1650 metres was momentarily inconvenienced when ARTFULABEERS shifted in. Raced keenly in the early and middle stages of the event. Laid in under pressure in the straight, and in the vicinity of the 50 metres shifted in onto CRAZY CULPRIT. Shortly after was taken back out into the running line of EYE THE WORLD.

EYE THE WORLD (K. Zechner) - in the vicinity of the 50 metres had to be momentarily steadied when TYCOON DREAMING was taken out into its running line.

REIGNING IN PARIS (E. Boyd) - had difficulty obtaining clear ground from the vicinity of the 600 metres until near the 300 metres.

RACE 6: BK & BJ SOUTHAM TV & LINE INSTALLATION BENCHMARK 62 HANDICAP - 1210 Metres

PAULO PACE (S. So) - in the vicinity of the 50 metres was disappointed when attempting a run to the outside of TAJAVEDO, which shifted out slightly.

SOCIAL MEDIA (M. Collett) - laid out under pressure in the straight.

FEARLESS AL (S. Logan) - underwent a pre-race veterinary examination at the barriers and passed fit to race. Shifted out on jumping away and bumped JUSTICA, and shortly after made contact with that mare for a number of strides when taken out by PAULO PACE.

JUSTICA (J. Toeroek) - shifted in on jumping away and bumped FEARLESS AL, and shortly after made contact with that gelding for a short distance when taken out by SHEZA LITTLE POSH. Rider reported that the mare was not comfortable in its action on pulling up. A post-race veterinary examination revealed a small laceration to its off fore cannon.

TAJAVEDO (E. Boyd) - raced wide without cover throughout the event. Laid out over the concluding 100 metres and in the vicinity of the 50 metres shifted out onto PAULO PACE.

SHEZA LITTLE POSH (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: JOHN'S QUICK CLEAN BENCHMARK 52 HANDICAP - 1390 Metres

GOTTABITON (J. Toeroek) - stepped a discoloured section of the track shortly after the start and lost ground. Inclined to lay in from the entrance to the straight until the vicinity of the 100 metres. In the vicinity of the 50 metres was contacted and inconvenienced when taken in by UNSCOPEABLE.

SIR GARFIELD (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

ANGEL'S WISH (S. Logan) - slow to begin. Shifted in under riding over the concluding 50 metres contacting GOTTABITON. Rider was reprimanded and advised in future to stop riding and make an effort to straighten her mounts sooner than she had on this occasion.

CHUCKLES (M. Collett) - raced keenly in the early and middle stages of the event.

VICTORY SPOILS (E. Annells) - slow to begin. Raced wide without cover throughout the event. Stewards questioned rider in relation to her riding in this event. Rider explained that she was unable to obtain a position closer to the fence despite her efforts, and as a result was forced to race extremely wide on the track throughout. Stewards noted her explanation.

RACE 7: JOHN'S QUICK CLEAN BENCHMARK 52 HANDICAP - 1390 Metres (Cont'd)

UNSCOPEABLE (T. Voorham) - when questioned regarding her instructions in this event, rider explained she was instructed to find cover if possible however, when the mare jumped away extremely well she felt it would be detrimental to restrain and attempt to obtain cover and rather than be caught wide, she elected to position outside the leader. She added in her opinion the mare would be better suited with cover.

THE MOSHIRE (S. Fawke) - in the vicinity of the 700 metres rolled in slightly onto RAYLEIGH.

RAYLEIGH (S. So) - in the vicinity of the 700 metres rolled out slightly at the same time as THE MOSHIRE rolled in resulting in the mare being obliged to be steadied momentarily and lose ground.

RACE 8: MCDONALDS PORT LINCOLN BENCHMARK 52 HANDICAP - 1390 Metres

OBLIQUE LINE (S. Logan) - laid in under pressure in the straight.

DASKULYA (J. Toeroek) - shifted out slightly on jumping away onto RUNAWAYSUZIE (NZ). Raced keenly in the early and middle stages of the event. Laid out under pressure in the straight. In the vicinity of the 200 metres shifted out onto the heels RUNAWAYSUZIE (NZ) and had to be steadied. Rider reported the gelding hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

KHANI STAR (S. Fawke) - shifted in under riding approaching the finish onto ART MUSIC. Rider was reprimanded and advised to take greater care. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$300.

ART MUSIC (C. Jones) - had to be steadied approaching the finish when KHANI STAR shifted in.

HARDASHIAN (A. Jordsjo) - shifted in shortly after the start onto RUNAWAYSUZIE (NZ). Raced wide without cover throughout the event.

RUNAWAYSUZIE (NZ) (K. Zechner) - hampered shortly after the start when tightened between HARDASHIAN, which shifted in and DASKULYA, which shifted out.

RACE 9: MITTY'S CLASS TWO HANDICAP - 1000 Metres

The start of this event was delayed approximately six minutes.

OLD TRIESTE (L. Halliday) - a post-race veterinary examination revealed no visible abnormalities.

THE MASTER (E. Annells) - hung in under pressure in the straight.

SCARY GO ROUND (M. Collett) - dislodged its rider behind the barriers and recaptured shortly after. Underwent a pre-race veterinary examination and passed fit to race. Momentarily inconvenienced inside the 200 metres when ARTFUL AMBITION shifted out.

CHINESIS (A. Jordsjo) - required a gear adjustment on arrival at the barriers. Inconvenienced on jumping away when its hindquarters were contacted by VILANELLE.

VILANELLE (S. Fawke) - jumped away awkwardly and shifted out contacting CHINESIS.

ARTFUL AMBITION (K. Zechner) - inside the 200 metres shifted out onto SCARY GO ROUND.

BOTTLE AND BIRD (S. So) - inclined to lay out in pressure in the straight.

RACE 9: MITTY'S CLASS TWO HANDICAP - 1000 Metres (Cont'd)

SERIOUS MOONLIGHT (T. Voorham) - had to be resaddled on arrival at the barriers. Slow to begin. A post-race veterinary examination revealed a laceration to the off side shoulder. First aid administered.
