

THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Monday, 9 November 2020

TRACK: Good 4 (Track with some give in it)
Upgraded to a Good 3 at 2.42 pm retrospective to Race 3
(Track with good grass coverage and cushion)

RAIL: True

WEATHER: Fine

RACE 1: FLEURIEU MILK COMPANY HANDICAP - 1550 Metres

FRANKIE PINOT (J. Eaton) - was held up from the entrance to the straight until the finish and was untested to the line. Rider explained that she had been disappointed at the entrance to the straight when attempting a tight run between the heels of JOURNICA and ELUSIVE ROSE. She added that approaching the 300 metres she had shifted out to behind JOURNICA to give her the option should a run eventuate to either that gelding's inside or outside. She further explained that inside the 200 metres a run did present to the inside of JOURNICA, but as she encouraged her horse to take up that run it closed as ELUSIVE ROSE shifted out resulting in her being held up to the finish.

DEEP FORCE (B. Vorster) - raced keenly in the early and middle stages of the event.

REX GOLIATH (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

ELUSIVE ROSE (K. Zechner) - raced keenly in the early stages of the event. Laid out under pressure over the concluding 150 metres.

CROWN HARMONIUM (S. Fawke) - jumped away awkwardly. Had difficulty obtaining clear ground from the vicinity of the 400 metres until near the 200 metres.

RACE 2: HOLDFAST INSURANCE HANDICAP - 1550 Metres

TUBBY TWO TRACKS (D. Caboche) - shifted out on jumping away contacting RAISE AN ARMY.

LADY CONQUISTADOR (J. Holder) - raced keenly in the early and middle stages of the event.

RAISE AN ARMY (T. Voorham) - contacted on jumping away.

DETENTORE (NZ) (D. Tootell (Snr)) - lost its off hind plate during the event.

RACE 3: SCHWEPPE HANDICAP - 1000 Metres

VIDUKA (C. Jones) - raced wide without cover throughout the event.

RACE 3: SCHWEPPE'S HANDICAP - 1000 Metres (Cont'd)

LORD VARYS (J. Toeroek) - was held up from the vicinity of the 400 metres until near the 300 metres where it was obliged to be eased and alter course to the outside of VIDUKA to obtain clear ground.

SANBUCK (D. Caboche) - rider reported that he had become concerned with the gelding's action shortly after straightening and for this reason had not ridden out in his normal manner. He added that in his opinion the gelding may not have appreciated the firm track. A post-race veterinary examination revealed no visible abnormalities.

GIVE ME A DOLLAR (D. Tourneur) - jumped away awkwardly.

DANTREE (A. Jordsjo) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

RACE 4: LICOLA'S 40TH HANDICAP - 1400 Metres

LEFT HAND MAN (S. Logan) - saddle shifted shortly after the start placing the rider at a severe disadvantage for the remainder of the event. Packing from the saddle dropped in the vicinity of the 500 metres. Rider weighed in approximately 6 kilograms light, and as a result LEFT HAND MAN was disqualified from the event in accordance with AR209(2)(a).

WHYKAYOH (J. Eaton) - taken wider rounding the home turn. Laid in under pressure in the straight. Rider reported that the gelding became unbalanced when taken wider rounding the home turn.

HANKSTAR (C. Jones) - contacted on jumping away.

KYSHAKA (T. Voorham) - jumped away awkwardly and shifted out contacting HANKSTAR. Approaching the 100 metres was accidentally struck by the whip of C. Lions. A post-race veterinary examination revealed no visible abnormalities.

DAZZLING DAMSEL (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

EXALTED TRAVELLER (R. Hurdle) - slow to begin.

SUPERVELOCE (NZ) (C. Lions) - raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres. Approaching the 100 metres rider accidentally struck KYSHAKA on the head with her whip.

RACE 5: ADELAIDE GALVANISING HAPPY TRAILS SERIES FINAL - 1400 Metres

FAROOQ (D. Tourneur) - slow into stride.

SILVERHAWK (T. Pannell) - a post-race veterinary examination revealed a laceration to the near side hock. First aid administered.

COSMIC RHAPSODY (K. Crowther) - raced keenly in the early and middle stages of the event. In the vicinity of the 200 metres shifted in and away from MAGNETIC EDGE onto LA RICHESSE.

PERFECT COMMAND (T. Voorham) - momentarily held up rounding the home turn.

KINGSON (K. Zechner) - shifted in, in the vicinity of the 1200 metres onto SKILLED BUNCH, which was taken in onto YOU HADME AT HELLO. Rider was reprimanded and advised in future to ensure he was sufficiently clear prior to shifting ground.

RACE 5: ADELAIDE GALVANISING HAPPY TRAILS SERIES FINAL - 1400 Metres (Cont'd)

YOU HADME AT HELLO (J. Eaton) - in the vicinity of the 1200 metres had to be momentarily steadied when **SKILLED BUNCH** was taken in. Rider reported that the mare was in season and it had affected its barrier manners.

SKILLED BUNCH (P. Gatt) - taken in, in the vicinity of the 1200 metres onto **YOU HADME AT HELLO**.

LA RICHESSE (J. Holder) - jumped away awkwardly and shifted out onto **MAGNETIC EDGE**. In the vicinity of the 200 metres was unbalanced and had its hindquarters turned when contacted by **COSMIC RHAPSODY**. A post-race veterinary examination revealed no visible abnormalities.

MAGNETIC EDGE (J. Maund) - contacted on jumping away. In the vicinity of the 200 metres shifted in towards **COSMIC RHAPSODY** to obtain clear ground. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by rider and noted that he used his whip on 12 occasions over the last 100 metres.

SPACE EQUITY (D. Caboche) - slow to begin.

RACE 6: TAB HANDICAP - 1300 Metres

VON SAGA (S. Logan) - jumped away awkwardly and shortly after was hampered when contacted by **LEONARDA**. Raced fiercely in the early and middle stages of the event.

LIKE A HEARTBEAT (J. Eaton) - lost its position on jumping away when tightened onto **WOUNDED SOLDIER (NZ)** by **MISS MOSH**.

WOUNDED SOLDIER (NZ) (T. Pannell) - eased out of the event in the vicinity of the 300 metres. A post-race veterinary examination revealed a bi-lateral bleed. Trainer, Mrs K. Byrnes, was advised that as this was the gelding's first bi-lateral bleed it would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

MISS MOSH (P. Gatt) - lost its position on jumping away when tightened onto **LIKE A HEARTBEAT** by **CANIDAE**. Laid out under pressure in the straight.

RAHEEBA (D. Caboche) - jumped away awkwardly and shifted out onto **LEONARDA**. Raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

CANIDAE (S. Fawke) - jumped away awkwardly and shifted out abruptly onto **MISS MOSH**. Had difficulty obtaining clear ground from the entrance to the straight until approaching the 100 metres. Stewards questioned the rider in relation to his riding in the straight. After considering his explanation, Stewards advised him in future to ride in a manner that did not invite question, as in the opinion of Stewards, there may have been a run presented to the inside of **VON SAGA** sooner than the one he elected to take to that mare's outside.

LEONARDA (R. Hurdle) - taken out on jumping away by **RAHEEBA** onto **VON SAGA**.

RACE 7: TERRY HOWE PRINTING HANDICAP - 1000 Metres

I REMEMBER YOU (T. Pannell) - jumped away awkwardly and was slow into stride.

ARROW LANE (S. Fawke) - in the vicinity of the 100 metres had to be steadied momentarily and altered course to the inside of **RUBY'S REWARD**, which shifted out.

RACE 7: TERRY HOWE PRINTING HANDICAP - 1000 Metres (Cont'd)

PORT VALE (O. Ridge) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by rider and noted that he used his whip on five occasions over the last 100 metres.

TINTAGEL ROCKER (A. Jordsjo) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by rider and noted that she used her whip on four occasions over the last 100 metres.

RUBY'S REWARD (D. Tourneur) - laid out under pressure in the straight. In the vicinity of the 150 metres shifted out onto ARROW LANE.

MRS HYDE (S. Logan) - jumped away awkwardly and knuckled shortly after the start. A post-race veterinary examination revealed no visible abnormalities.

LITTLE RICH BOY (J. Eaton) - raced keenly in the early and middle stages of the event. Hung out rounding the home turn. Rider reported the gelding hung out throughout the event.
